# SHL is More Than an Annual Session

**T**he Missouri Silver Haired Legislature (SHL) Handbook is truly a well written guide to who we are and what we do. As outlined in the Handbook, we have an obligation to **“Assess the legislative needs and priorities of older Missourians by convening a forum modeled after the Missouri General Assembly.”** We fulfill this phase of our mission every October. SHL delegates from all over the state assemble in the House and Senate chambers of the Missouri State Capitol. We follow Roberts Rules of Order in a legislative session very much like the state and federal government. The delegates of the SHL will hear expert testimony, engage in debate, attend committee sessions, and eventually reach a consensus on our top 5 priorities we will advocate for. This may be the most difficult and time-consuming part of our obligation as delegates of the Missouri Silver Haired Legislature. It is a little unusual that this most involved and complicated task *is not the most important part of our mission.*

As an SHL delegate, we are much more than the October annual session. We will reach out to our Senators and Representatives throughout the year and particularly during the 2026 session of the General Assembly. The Handbook states:

**“Interacting with your legislators encourages support for SHL issues and legislative priorities - either in introducing bills or supporting their passage.”**

Embrace the priority issues that are most important to you and your loved ones, and then pursue them with the decision-makers in Jefferson City. Check out the House and Senate Joint Bill Tracking tool at

**Y**ou can also reward the hours of work by the SHL Advocacy Committee by always acting upon the weekly advocacy reports that you receive electronically. It is so easy and very important to make a friendly visit, make a phone call, leave a message, or send an email, and to do so on a regular basis. Reach out with whatever method works best for you.

Missouri State Budget Director Dan Huang said, “The Governor has been pretty transparent and pretty vocal that this is going to be a very difficult budget year.” This makes it even more important that our legislators understand that an investment in aging is a wise economic decision that has a measurable fiscal benefit for the State of Missouri. Julie Peetz, Executive Director of ma4, emphasized that we must stop allowing aging services to be framed as a cost. The SHL Priority Issues that we support save tax dollars by helping your neighbors age in place

in their home, instead of a taxpayer funded nursing facility. We should be proud of the fact that we are not only advocating to help our neighbors live and age with dignity, but we are also advancing fiscally responsible public policy.

In my eight plus years as a delegate of the Missouri Silver Haired Legislature, I have never met a Senator or Representative that was less than courteous. We are a non-partisan issue-

#### Acceptable Forms of Voter ID

- A nonexpired Missouri driver or non-driver license; A nonexpired military ID, including a veterans ID card;
- A nonexpired United States passport; or Another photo ID issued by the United States or the state of Missouri which is either not expired or expired after the date of the most recent general election.

If you do not possess any of these forms of identification, but are a registered voter, you may cast a provisional ballot. Your ballot will count if: (1) you return to your polling place on Election Day with a photo ID; or (2) the signature on your provisional ballot envelope is determined by your local election authority to match the signature on your voter registration record. If you cast a provisional ballot, you will receive a stub from your provisional ballot envelope with instructions on how to verify that your provisional ballot is counted.



If you are unable to vote in-person because of any difficulties it poses for you, please request to be put on the **"Permanent Absentee Voter List"** by contacting your local election authority. **It's that easy!** Once you are on this list, your local election authority can automatically mail an absentee ballot application directly to you prior to each election. You will need to make this request directly to your local election authority who will send you further information.

# Taxing Matters: “I DON’T KNOW”

Four decades of college teaching taught me that there is no such thing as a dumb question. Similarly, there is no shame in admitting that I don’t have all the answers.



I am reminded of this by the initial responses to Governor Kehoe’s announcement of his intent to eliminate the state personal income tax or, more precisely, to replace it with a different set of taxes. It would be an understatement to say that feelings are strong on both sides!

Is this a good idea? *I don’t know*. Can it be successful? Again, *I don’t know*.

So rather than speculate, let’s start with some facts. Since the governor suggested we look at pre-COVID spending patterns, let’s go back to 2019. In FY2019 Missouri’s annual expenditures totaled \$28.3 billion.<sup>1</sup> Of that amount, the state collected net general revenue (basically income and sales tax collections) of approximately \$9.4 billion. And of that amount, individual income taxes collected totaled about \$6.6 billion. So, individual income taxes constituted about 70.2 percent ( $= 6.6/9.4$ ) of general revenue.

Now consider the most recent year. Missouri’s annual expenditures in FY2025 totaled \$51.8 billion, an increase of 80 percent (!). Net general revenue totaled approximately \$13.16 billion. Individual income taxes generated \$8.3 billion – 63 percent of the total.


So – from 2019 to 2025, state expenditures nearly doubled, general revenues increased 40 percent, and individual income tax collections increased by about 26 percent. In sum, individual income tax collections *increased* despite sequential reductions in the top state income tax rate, while they *fell* as a proportion of general revenue by 10 percentage points ( $= -7/70$ ).

Now to the hard part. The biggest unknown is what a proposed tax system would look like. As this column is being written, nothing specific has been proposed, apart from the Governor’s statement that he “would not raise sales taxes on agriculture, healthcare, or real estate.” Some have concluded that this means a massive increase in all other sales taxes. That may or may not be the case, but again, *I don’t know, and neither does anyone else outside of the Governor’s office*.

The bottom line is this: knee jerk reactions (in either direction) to the governor’s announcement are not helpful. My suggestion is to stay calm, wait for plan details, and then decide whether to oppose or support the plan based on its merits (or lack of them). For the moment, let’s not be afraid to say, “I don’t know.”
